

Public Safety Review Panel
Minutes for the Meeting of: June 18, 2019
Conducted via Conference Call

- **Call to Order:**

The meeting convened via conference call at approximately 10:05 a.m. with a quorum of members present: Kari Reardon (Vice-Chair), Terri Mayer, Katherine Michaelsen, Mark Griffiths, and non-voting Lisa Wolph and Lori Melchiori.

- **Business Meeting: (10:05 – 10:15)**

A. Minutes for the May 21, 2019 PSRP meeting were approved as written.

B. Discussion of the draft minutes from the in person June 5th meeting at ESH: members requested these be reviewed at the next meeting when the Chair is present.

C. Staff Update:

a. Staff were provided a draft copy of the revised hospital procedures for patients to request or petition court for Conditional or Unconditional Release. Staff are currently working with the hospitals and Dr. Kinlen regarding language in the proposed procedure that would not refer patient requests to the PSRP if they are not supported by the Risk Review Board. An update will be provided at next month's PSRP meeting.

b. This month staff was informed that the hospitals changed the process for Prosecutors and Defense Attorneys to obtain copies of the PSRP referral packets from the hospital for their review and input. They have been instructed to request the materials through Public Disclosure. This will not provide the information in a timely manner that will allow input to the PSRP prior to case reviews. Staff are currently working with the attorneys and the hospitals to identify and put in a place a request process that will expedite providing the information to the attorneys of record.
